I/We release the City of Newport, it's successors and assigns from any and all responsibility of liability for injuries or damages to the user of the equipment listed on this form or to any other person or property. I/We will not make a claim against the City of Newport, it's successors or assigns for injuries or damages relating to the storage of my kayak/Canoe.

I/We hereby agrees to defend, protect, indemnify and hold harmless the City of Newport, it's successors and assigns from, all claims, actions, proceedings, costs damages, and liabilities, including attorney's fees, arising out of, in any way connected with, or resulting from my/our use of leased storage equipment, including without limitation the possession, use operation, or return of the equipment, including any such claims whish allege negligent acts or omissions on the part of the City of Newport, it's successors or assigns.

RENTAL TERMS

The storage equipment, at all times, remains the exclusive property of the City of Newport. I/We am/are responsible for damage to or loss of the equipment. If the equipment is lost, destroyed or damaged beyond repair in the judgment of the City of Newport, I/We agree to pay the City of Newport the value of the equipment. All repairs needed as a result of the use of the equipment will be performed at the normal labor rates and the cost of such repairs, including all parts, shall be paid by me/us.
